The following is the report of the Sub-committee:

The Sub-committee recommends that steps be taken to raise the income of the Association by—

- (i) procuring more advertisements for the Journal;
- (ii) increasing the number of members;
- (iii) raising donations;
- (iv) increasing the rates of subscriptions of the members
- (v) approaching the Administrative Officer of the Corporation of Calcutta for revising the Annual Library grant;
- (vi) finding ways and means to curtail expenditure where possible.

The Sub-committee further recommends that a proposal should be made to enlist life-members on payment of 10 years' subscription in one instalment (except Graduates and Students). This may induce many members to become life-members thereby benefiting the Association

With regard to item (iv) the Sub-committee recommends the following revised scale of subscriptions and admission fees:

The Resolution of the Council regarding enhancement of the cates of subscriptions and admission fees as well as fees for life-membership was ratified with the exception of the admission fee for the Associate Members which was amended as Rs. 10/- instead of Rs. 5/-.
