1. The Council expressed its deep sense of sorrow on the demisê of Sri Kshirode Mohan Mukherji, B.A., B.E., M.I.E., M.A.E., who had been a very ardent and energetic member of the Association since July 1927 and Vice-President for 5 years (1937-41) and President for 3 years (1943-45), and conveyed its sincere condolence and sympathy to the bereaved family of the deceased.

The Banking Corporation agreed to allow the tenancy to continue for six months only. The Council also decided that the service of Sri J. C. Bhattacharyya as the office superintendent was to continue as usual.
